### CES 2022 Health Protocols

#### **PLANNING FOR CES 2022**

CES 2022 is returning to Las Vegas for a live, in-person event. Over 1100 companies including major brands and start-ups will be in Las Vegas January 5-8. We remain focused on bringing you the most influential tech event in the world.

Safety, security and health are a priority at CES. We will continue to evaluate and expand our health safety protocols as medical recommendations evolve. We will update this page regularly as protocols change so you know what to expect when you arrive in Las Vegas for CES.

Las Vegas opened its doors to tradeshows in June and we've have been adapting our plans based on new and evolving information for events. Travel and events have changed and so has CES. We want to ensure CES continues to help you make the connections you need to meet your customers; given your business and your brand.

#### PROOF OF COVID-19 VACCINATION REQUIRED

All attendees and exhibitors will need to show proof of COVID-19 vaccination in order to attend CES in Las Vegas. Attendees and exhibitors will need to be fully vaccinated with a vaccine approved or approved for emergency usely the FDA or World Health Organization (WHD). A list of approved vaccines can be found

CES will use CLEAR to administer proof of vaccination for U.S. based attendees. CLEARs free mobile app and Health Pass feature provides a simple and secure way for this information to be shared. For non-U.S. based attendees, we will use a similar, 3rd parry platform to submit proof of vaccination. We will share more information on this in October.

CTA continues to monitor guidelines for health safety measures from the Centers for Disease Control and Prevention. Nevada and Clark Councy. CTA will follow applicable federa; stee and local laws, adapting CES plans accordingly and sharing updates with you and other CES audiences. We are also working closely with the Las Yegas community, including the Las Yegas Convention and Visitors Authority, exhibit venues and hotels, and if they adjust their plans, we will communicate that as well. - Event has announced new cleaning and sanitization program
- Lots of planning to enable social distancing including widening aisles, providing more space between seats in seminars and wherever attendees congregate, sanitizer stations throughout
- All exhibitors have a clause in their stand/booth contract that brings a full refund if COVID forces a CES 2022 shut down. Refund or roll investment to 2023.





## The Layout





Over 65,000 square feet of paved space in a high visibility parking lot of the Las Vegas Convention Center

## The Offer


- All spaces are 10-feet by 10-feet (3-meter by 3-meter) and ready for *your* pop-up tent. Spaces are all outside and are paved and include trash pick up; suitable for up to 5 bikes or 10 scooters. *Product beyond Class 1, 2 & 3 ebikes will need to be reviewed and pre-approved for on-test track use.*






#### **eMobility Experience Registration:**
